Proposed Bylaw Revisions

Wheatland Electric Cooperative, Inc. (WEC) Board of Trustees has proposed the following amendments to the cooperative's bylaws. These proposed changes will be voted upon by the membership as part of the **2025 ANNUAL MEETING ON APRIL 23, 2025.** WEC encourages you to review the proposed changes affecting multiple sections of the bylaws. The foundation to any successful cooperative is member trust and transparency in decision-making. If you have questions regarding the proposed bylaw changes, please email memberservices@weci.net. You are hereby notified, pursuant to K.S.A. 17-4608 and Article 12 of the bylaws, that the following proposed amendments to the bylaws are being submitted to a vote of the membership at the annual meeting, April 23, 2025. Proposed changes are outlined in red below.

THE WEC BOARD OF TRUSTEES RECOMMENDS ADOPTION OF THE FOLLOWING CHANGES TO THE BYLAWS OF WHEATLAND ELECTRIC COOPERATIVE,

INC. A "yes" vote is a vote in favor of the proposed changes. A "no" vote is a vote against the proposed changes. A complete version of WEC's current bylaws can be found at www.weci.net/co-opbylaws.

WEC TRUSTEES' BALLOT PROPOSAL 1

The Wheatland Electric Cooperative, Inc. Board of Trustees recommends the following bylaw changes regarding the a) qualifications to be a trustee, b) the notice requirement of new business at an annual meeting, and c) mail-in ballots for the election of trustees of approved nominees. All proposed changes are in red font letters.

"COOLING OFF" PERIOD FOR FORMER EMPLOYEES FOR THE ELECTION OF TRUSTEES

ARTICLE 4, SECTION 3.

No person shall be eligible to become or remain a trustee or to hold any position of trust in the Cooperative who:

- 1. Is not a member and taking electric service in the area served or to be served by the Cooperative; or
- Is in any way employed by or financially interested in a competing enterprise or a business selling electric energy or supplies to the Cooperative, or a business primarily engaged in selling electrical or plumbing appliances, fixtures, or supplies to the members of the Cooperative.
- 3. Has a close family member that is an employee of the Cooperative. A close family member means a spouse, parent, child, sibling, grandchild, grandparent, aunt, uncle, niece, nephew and the same for in-law and "step" relationships.
- 4. Was an employee of the Cooperative within three (3) years of being appointed or being elected as a Trustee of the Cooperative.
- 5. Does not meet all qualification requirements as set forth in Cooperative policy adopted by the board of trustees.

ADDING NEW BUSINESS TO AN ANNUAL MEETING WITHOUT PROPER NOTICE

ARTICLE 3 SECTION 7: SECTION 7. ORDER OF BUSINESS.

The order of business at the annual meeting of members and, so far as

- possible, at all other meetings of the members, shall be essentially as follows:
 Report on the number of members present in person in order to determine the existence of a quorum.
- 2. Report on the number of members represented by proxy and the names of their respective proxies.
- 3. Reading of the notice of the meeting and proof of the due publication or mailing thereof, or the waiver or waivers of notice of the meeting, as the case may be.

- 4. Reading of unapproved minutes of previous meetings of the members and the taking of necessary action thereon.
- 5. Presentation and consideration of reports of officers, trustees and committees.
- 6. Announcement of the election of trustees.
- 7. Unfinished business.
- 8. New business. Provided that any new business that would change or add a bylaw or a written policy of the board of trustees must be in full written text and provided as part of the notice of the meeting. Further, any new business items from the members must be requested in writing and served on the secretary of the Cooperative at least 45 days before the annual meeting of the members.
- 9. Adjournment.

NO WRITE-IN TRUSTEE CANDIDATES

ARTICLE 4 SECTION 2 ELECTION AND TENURE OF OFFICE. SECTION 2. ELECTION AND TENURE OF OFFICE.

Trustees shall be elected by mail ballot prior to each annual meeting of the members and shall be elected for a three-year term beginning on the date of the next annual meeting of the members. Members of the board of trustees shall not serve more than six, three-year terms beginning from and after adoption of this bylaw by the membership at an annual meeting. Trustees shall be elected by a plurality vote of those members casting mail ballots and tabulated as set forth in written Cooperative policy established by the board of trustees. The results of trustee elections will be announced at a properly convened annual meeting of the members. Only nominations by the committee on nominations and nominations by petition, as set forth in these bylaws, will be counted for the election of trustees.

WEC TRUSTEES' BALLOT PROPOSAL 2

The Wheatland Electric Cooperative, Inc. Board of Trustees recommends the following bylaw change regarding the qualifications to be a member.

To remove all references in Wheatland's Bylaws to "telecommunications service," or the like, in the Wheatland Bylaws, for purposes of membership and patronage capital, now that Wheatland no longer provides Broadband Telecommunication service.

Members should reference Table of Contents; Art. 1 Section 2; Article 1, Section 1, Section 2, and Section 3; and Article 7 Section 2, in the current Wheatland Bylaws found at www.weci.net.
