FROM THE MANAGER

Annual Meeting Recap & Pending Sales Tax Legislation Update

Thank you to all of our members who attended Wheatland Electric Cooperative's 67th Annual meeting in Syracuse.

We had 84 members register and served 125 barbecue meals to our members and guests. Thank you to all of the special guests who attended.

During the meeting, we presented the 2014 financial report, discussed the upcoming Automated Metering Infrastructure (AMI) installation, and provided a yearly summary on the activities and accomplishments of the cooperative in 2014. Wheatland presented our new scholarship program, and 10 high school students were recognized as the winners. We also recognized two Electric Cooperative Youth Tour winners and one Cooperative Youth Leadership Camp winner.

During the meeting, service awards were presented to Wheatland employees with awards ranging from five to 40 years.

Stuart Lowry, President and CEO of Sunflower Electric, Wheatland's wholesale power supplier,

presented an update on electric generation. The 2016 Annual Meeting will be held in Tribune.

Sales Tax Legislation

On another front, I'd like to discuss a serious tax issue that could affect your electricity bills in the future. As I'm writing this, the Kansas Legislature is contemplating removing the state sales tax exemption on residential utility bills. If Senate Bill 261 passes along with a corresponding House Bill, your electric bills will increase by 6.15 percent each month.

This would be a state tax and not a Wheatland rate increase. Nevertheless, we would have to collect the tax and send it to the state.

Wheatland and your member elected Board of Trustees are committed to being part of the solution, but we don't believe our members should carry the burden alone. We will update you on the outcome of SB 261 in the July issue.

Wheatland to Send Three Students to Washington and Colorado

Wheatland Electric's Board of Trustees has selected three students for Youth Tour trips courtesy of the cooperative. Wheatland selected **DERIAN GARRISON** of Norwich High School and **ESSENCE RATZLAFF** of South Haven High School for the Electric Cooperative Youth Tour to Washington, D.C., and **MALLORY HORTON** of Syracuse High School to the Cooperative Youth Leadership Camp in Steamboat Springs, CO.

Since 2014, Wheatland provided all 13 high schools in its service territory an opportunity to nominate a student for Youth Tour consideration. This year, six schools nominated students.

The candidates submitted essays on "the nature and philosophy of a cooperative business, comparing and contrasting it with an investor-owned corporation." They also demonstrated their poise and knowledge during interviews with a panel of Wheatland's board members.

"The students' essays were a wonderful reminder about what makes cooperatives unique," said Katie Eisenhour, one of the Wheatland board members in charge of the selection process and also a Cooperative Youth Leadership Camp alumni. "I think our generation knows all that cooperatives have done for rural communities, and it's nice to see that young people also recognize that contribution."

Here are some samples of what our winners had to say about cooperatives in their essays.

► "Cooperatives are based on the values of self-help, self-responsibility, democracy, and equality... profits

are put back into the cooperative to help run the business efficiently, or are returned to the customer-owner," Derian Garrison, said.

► According to Essence Ratzlaff, "Electric cooperatives were created to bring power to the rural areas... since investor-owned power companies refused to deliver power to these areas due to lower profit potential from having fewer customers per mile of powering."

► Mallory Horton's essay revealed that, "The difference between the two is like the difference between earning an item and being given one. I worked really hard to earn enough money to buy myself a Nintendo DS a few years ago and I take care of it because of the amount of time and money I put into it."

The Electric Cooperative Youth Tour to Washington, D.C., will take place June 11-18. The national trip is in its 51st year. In 1957, then-Senator Lyndon Johnson gave a speech to the National Rural Electric Cooperative Association and proclaimed,

"If one thing goes out of this meeting, it will be sending youngsters to the national capital where they can actually see what the flag stands for and represents."

The goals of the program are twofold: to teach students more about


how electric cooperatives work and to develop the leaders of tomorrow by exposing them to people and places outside of their own communities.

Today roughly 1,700 high school students attend each year, traveling to Washington from 45 participating states. More than 50,000 students have participated in Youth Tour since its inception.

Wheatland's 2014 winner was **BAILEY HARRIS** of Greeley County High School in Tribune. She said the trip was "one of the best experiences of my life thus far! I learned a lot from our conversations with legislators, and I really enjoyed getting to ask questions and speak with them on such a personal level."

The 2015 tour includes stops at the Smithsonian museums, Arlington Cemetery, the US Holocaust Memorial Museum, George Washington's Mount Vernon and the National Archives, as well as tours of the national memorials and monuments and meetings with Congressional staff members.

Closer to home, the Cooperative Youth Leadership Camp in Steamboat Springs, CO, has been educating students for more than 40 years. Students from Kansas, Colorado, Oklahoma and Wyoming attend. The goal is to give students a broader view of the world and educate them about cooperatives. On the agenda for this year's camp are visits to Look-out Mountain, Fish Creek Falls and Steamboat Springs, various leadership activities, white water rafting, and tours of Trapper Coal Mine and Craig Generation Plant.

Beat the Summer Heat with Cool Products

When temperatures soar in the summer, utility bills can do the same. There are several small ways to manage your energy use this summer. Wheatland Electric is happy to help you with those simple, no- or low-cost ways to save—but for those who are considering remodeling or making larger purchases, here are a few ideas that may help keep your energy use in check and keep your wallet cool.

If making changes to your heating and cooling system isn't the right upgrade for you now, consider installing a smart thermostat. These "cool" devices learn your behavior and adjust heating and air conditioning settings with a goal to save energy. Smart thermostats also have the capability to connect to the Internet, al-

lowing homeowners to manage energy use via a smart phone app. There are several smart thermostat options available on the market, typically costs range between \$200 and \$400.

Purchasing new appliances?

If you are considering purchasing new appliances that will use less energy, but may not have the budget for a complete appliance overhaul, start with replacing your clothes dryer. Dryers are big consumers of electricity, using around 900 kWh each year as compared to a refrigerator, which uses around 455 kWh each year.

There have been big developments with dryers in recent years, and Energy Star awarded two standouts—the LG EcoHybrid Heat Pump Dryer and the Whirlpool HybridCare™ Heat Pump Dryer—the 2014 Emerging Technology Award.

Using heat pump technology, these dryers offer 40 percent in energy savings if operated on their most efficient settings and can save more than \$400 over the life of the dryer. Remodeling?

If you are making esthetic changes to your home, consider products that will also make it work more efficiently. Heating and cooling systems use the most energy in our homes, so if you are making upgrades to your floors and cabinets, consider making some energy efficient upgrades, too.

If you're making additions to your home or converting attics or basements into living spaces, a ductless heating and cooling system is a great option. A ductless system does not require adding pipes or ductwork to a home's existing system, making it a more affordable upgrade for many. Ductless systems tend to be more efficient, meaning homeowners will use less energy and save on their

Two heats, divided into three classes, (standard, solar and open) raced to see who could get the most number of laps in an hour. The results were compiled and the top three finishers in each division were awarded plaques.

Along with sponsoring two of the teams in the rally (Great Bend and Scott City), Wheatland was happy to furnish lunch for all of the participants, faculty sponsors, spectators and volunteers. A special thanks goes out to

When most people think of Wheatland Electric, they think of electricity. But did you know that Wheatland also provides wholesale water? Part of Wheatland's mission is to provide other essential services to rural Kansas: including water supply. **PERRY SMITH** manages the water works for Wheatland.

I arrived at the reverse osmosis water treatment plant at 7:30 a.m. to start my day with Perry. He briefed his one-man staff, Francis Lobmeyer, and me on the day's work. Then off we went. Since Francis was holding down the fort at the water plant, Perry and I hit the road to take care of some field work. Within the first hour of our trip, Perry and I jumped in and out of his truck nine times to check on a variety of Wheatland water equipment and buildings.

As Perry explained to me, it is required that a daily visual inspection occur at many of the water sites, including; pumping buildings, the deep well injection building, and chlorination buildings, among others.

Our next adventure was to drive out to the water ranch. This is an area in rural Finney County where most of Wheatland's water wells are located. After driving through some rather rough terrain that had me holding on for dear life and squealing on one occasion, we stopped to put a fitting on a pipe for a temporary water supply then quickly moved on to other wells. Perry just kept trucking along: he has a non-stop, admirable work ethic.

A Day in the Life

As we continued on our journey, I asked Perry what was his favorite part about his job. He said that he preferred to work on the water ranch. He said that when he's out in a field smelling fresh cut alfalfa and seeing and hearing the sounds of the country as he's working, he feels at ease. We then moved on to inspect a chlorination station. As we walked into the building, I noticed a relief valve that lets a small stream of water run into a drain. Perry said the toad was a sort of house pet that had lived there happily for several years enjoying the fresh water and the occasional gourmet bug.

As we wrapped up our day together, Perry and I talked about life in western Kansas. Perry puts a priority on his family. He has several grown children and grandchildren who all visit regularly. He clearly loves his wife, Ann. With a softness in his eye, he said that she takes very good care of him and their home.

In starting my journey with Perry in the water works department, I had little idea of what he did on a daily basis. I now know that he and Francis work very hard managing and maintaining a complex system of equipment and piping all for the purpose of providing quality drinking water to thousands of people and businesses.
